From the desk of the Editor


The important agendas which were formulated last time continue to remain important to us. I am repeating some of the key agendas to emphasize their importance:

- ♣ Increase and strengthen the National associations and regional chapters of the WOC which represent the core strength of the organization. Clearly demarcate the relationship between the Central group and the local chapters.
- ♣ Have a uniform membership policy across the world.
- ♣ Many members are untraceable or have changed their emails.
 We need to find them and document their presence.
- ♣ The mailing lists are incomplete and need to be updated. We also need articles from around the world so that our readers are aware of the activities of the WOC and its members.
- ♣ A regular source of funding is required to run the organization.
- ♣ We must think about holding regular conferences for the organization, independent of SICOT activities and activities of other associated organizations. For this purpose, a proposal for a World Congress at Kolkata, India has been proposed for 2023 but will depend on the Covid situation and the financial health of the organization.
- ♣ In the past office bearers were chosen. But as the organization becomes larger (with more and more country members) a fair way of representation and election must be formulated.
- ♣ WOC must revive its humanitarian projects from around the world so that it can be a truly "caring" orthopaedic organization.

Dr Deven Taneja retires as President of WOC after playing a long innings at the helm of the organization in different roles. He will continue as Immediate Past President to guide us through our activities. WOC Intl thanks him for his selfless services and commitment to the organization.

The Next TKS medal was awarded to Dr Steve Manion of the UK. He has been associated with humanitarian and disaster management efforts worldwide and WOC could not have picked a more suitable recipient.

Volunteer services Deven Taneja

In July 1982 and again in 1992 I had the opportunity to go to Malawi in a project called "Malawi against Polio" (MAP) of Rotary international. I was the 5th specialty surgeon to serve the project and the first from India.

I was based in Lilongwe (Capital of Malawi) where the main part of the project was going on. I had seen few hundred patients of polio, club foot, neglected trauma and Osteomyelitis. I did more than 60 operations in 3 different hospitals and visited 2 rural clinics. I was also involved in the training of Orthopaedic assistants. My last week was spent in Blantyre. I enjoyed my stay in Malawi and I am happy to put it on record that on my second visit to Malawi I did not see any new Polio patients. My stay and social interaction was very pleasant.

I went to Indonesia as a visiting Prof. under WOC program at Hissamuddin University. My one month stay at Ujuang Pandang was very productive. Most of the work was on neglected trauma and infections. I had the opportunity to train the doctors and technicians.

I also went as a TKS visiting professor to Bhutan under the Health Volunteer Overseas, USA which is again under the WOC International Program. Most of my work was on Neglected Trauma, especially the spinal injuries and infections. I was also training young doctors on the basics of Orthopaedics. I participated in an excellent symposium organized by the Army. Working with the Orthopaedic overseas, Rotary International & WOC gave me an immense satisfaction & happiness of having made as much of a contribution as I could to needy and poor patients.

I made many friends with whom I am still in touch with. I thank all the organizations for giving me an opportunity to serve the ailing society in LMIC.

I appeal to the youngsters to come forward to volunteer their services to these countries.





AO Alliance: Partnering to strengthen care of the injured in lowand middle-income countries (LMICs)

Since 2015, the AO Alliance has trained over 20,000 healthcare workers, including trauma and orthopaedic (T&O) surgeons, operating room personnel, doctors in training (residents or registrars), paramedics, orthopaedic clinical officers, in 24 countries in Sub-Saharan Africa and 8 countries in Asia, on the basic principles of fracture management, both operative and nonoperative.

To mark the first six years of existence, AO Alliance board members, under the leadership of Rolf M Jeker, and former members Jaime Quintero and Joachim Prein, elected to document the history and evolution of the AO Alliance. The book explores the contribution of the AO Socio-Economic Committee (AO SEC) in advancing fracture care in LMICs, analyzing the human and economic burden of injury and disability in these countries. The authors describe the process leading to the AO Alliance's creation, map its governance, policies, strategies, funding, and partnerships, charting its progress, and exploring its future.

AO Alliance Country Initiatives

The AO Alliance has established four national capacity building programs in Ethiopia, the Gambia, Ghana, and Malawi, addressing gaps in infrastructure, human resources, training, and clinical data.

The Gambia

With cooperative funding from AO Trauma, the Gambia Country Initiative was launched in 2019 under the leadership of Dr Kebba Marenah, chief of surgery at the Edward Francis Small – Teaching Hospital and CEO, Dr Charles Roberts.

A young T&O surgeon, Dr Mariam Joof, has returned to the Gambia from her residency training in Senegal, supported by the AO Alliance Gambia Country Initiative. The Gambia thus has, in 2020, a second national T&O surgeon to serve the country's population of 2.3 million.

Dr Musa Ka, currently training in Russia, will be returning to the Gambia in 2022 to further increase the number of national T&O surgeons. Dr Mariama Suso, a promising Gambian trainee, is completing a T&O residency at an AO Alliance partner hospital in Malawi, the Queen Elizabeth Central Hospital. She is due to qualify as a T&O surgeon in 2026.

Burkina Faso

In 2021, the Burkina Faso Country Initiative was launched, with five main goals: To improve the technical portfolio of the university teaching hospitals; to improve the knowledge, skills, and attitudes of healthcare workers caring for fractures; to develop trauma registries; to raise awareness of the burden of injuries as a public health issue; and to collaborate with the national trauma and orthopaedic association to build a national community of practice. This is the AO Alliance's first national capacity-building program in French-speaking Africa. The initiative was developed after a thorough needs assessment carried out in July 2019.

COVID-19 Response Program



The AO Alliance's first response in February 2020 to the pandemic was to develop a strategy to keep our local faculty networks safe and healthy. Since then, the AO Alliance has been supporting local projects to procure personal protective equipment (PPE) as those needed for T&O staff in the operating theatres were and continue to be diverted to emergency rooms, leaving our T&O surgeons and operating room

personnel unprotected. The below activities form part of the COVID-19 response:

- a. Local capacity solutions to produce PPE
- b. Procurement and distribution of PPE for surgical teams in AO Alliance countries
- c. Technical support for COVID-19 surgical protocols (return to surgery)
- d. Manpower recruitment (anaesthesia clinical officers) to maintain surgical throughput
- e. Treatment subsidies for paediatric surgical cases (Beit CURE Malawi Hospital)

AO Alliance Online: Fracture care education



The AO Alliance is developing a free online education platform covering injuries to the distal upper extremity (radius) and a comprehensive program for fracture-related infections (prevention, diagnosis, and treatment). The content is designed for low-resources settings. AO Alliance Online will go live in October 2021.

The Harvard Global Orthopaedics Collaborative (HGOC) is a group of Harvard-affiliated orthopaedic surgery faculty and trainees who share a passion for improving access to musculoskeletal health care globally. We engage in clinical research, surgical education, care delivery, and health systems development with our global partners in Cameroon, Colombia, Haiti, India, Malawi, and South Africa. We collaborate with the Harvard Program for Global Surgery and Social Change (PGSSC),

the Orthopaedic and Arthritis Center for Outcomes Research (OrACORe), and the Harvard Medical School Orthopaedic Trauma Initiative (HMS OTI).


<u>Haitian Annual Assembly of Orthopaedic Trauma (HAAOT), Port-au-</u> Prince, Haiti

HAAOT is an annual conference started in 2013 aimed at improving knowledge and skills of Haitian orthopaedic residents and staff. The conference consists of research paper presentations, case discussions, didactic lectures, and workshops, all of which are presented in both English and French. It is organized every year in conjunction with the Harvard Combined Orthopedic Residency Program alongside all three major orthopedic residency programs in Haiti. For the last two years, the conference has been virtual due to the COVID-19 pandemic and

political unrest in Haiti. The HAAOT/HGOC network has been put into action by collecting and donating essential supplies to manage patients affected by the 2021 earthquake in Haiti.

<u>Improving access to</u> <u>musculoskeletal trauma care in</u> <u>Malawi</u>

Our research approach
Guided and in collaboration with our local partners



We are working in collaboration with Queen Elizabeth Central Hospital, Kamuzu Central Hospital, the AO Alliance Foundation, and the Malawian Ministry of Health on a variety of projects aimed at improving access to musculoskeletal trauma care in Malawi, particularly for the rural poor. We have examined risk factors for delayed presentation to hospital, health system navigation by patients with femoral fractures, the financial impact of injury on patients with femur fractures as well as the cost effectiveness of treatment (in collaboration with UCSF IGOT), and the capacity to manage musculoskeletal trauma in the public hospitals. We are translating our research findings into policy recommendations, educational programs for clinical staff, and the development of standardized protocols for clinical care.

Low-cost negative pressure wound therapy in Cameroon

Learning from our colleagues in Haiti, and addressing a need expressed by our colleagues in Cameroon, we built low-cost negative pressure wound therapy (NPWT) pumps which are now being used for clinical care by our partners in the Cameroon Baptist Convention Health Services hospitals. We are investigating the feasibility and clinical efficacy of using these devices in the Cameroonian context to help manage open fractures. Feedback from our Cameroonian colleagues helped us improve our design of the NPWT pumps, and improved versions were recently sent to Cameroon and Haiti in response to the 2021 earthquake.

<u>Understanding and addressing the need for hand surgery in sub-Saharan Africa</u>

This study is in collaboration with our partners in Queen Elizabeth Central Hospital, Malawi; Sourou Sanou University Hospital of Bobo-Dioulasso, Burkina Faso; CHU Aristide Le Dantec, Sénégal; Omdurman Islamic University, Sudan; and the AO Alliance. We are working with clinical providers across sub-Saharan Africa to identify the most common hand and upper extremity pathologies in each country and the local capacity to manage these conditions. The goal is to develop priorities and core competencies for training in hand surgery by country and region.

HGOC educational videos, digital distance learning

We are developing high-yield educational videos on a variety of orthopaedic topics relevant to orthopaedic residents, surgeons, non-physician clinicians, and non-surgeon physicians who manage patients with musculoskeletal injuries or diseases in the low resource setting. We are organizing in-person and virtual conferences on orthopedic trauma management in Haiti, Malawi, Libya, and Colombia.
